9:00 – 5:00	<p>Pre-Conference Seminar — Introduction to Children with Problematic Sexual Behaviors, Safety Planning, Reunification, Caregiver Engagement and Ways to Move the State Forward in this Work</p> <p>Andrew Monroe MSW, LICSW, LCSW</p> <p>During this session participants will be able to describe guidelines and strategies to facilitate examining sexual behavior of children and distinguish typical and problematic sexual behavior, identify common misconceptions regarding children with problematic sexual behavior of youth, learn how choice of words can impact thoughts and behaviors when addressing problematic sexual behavior of youth, gain understanding of caregiver perspectives on strategies professionals can utilize to facilitate family engagement, learn about factors that impact placement decisions for children who have problematic sexual behavior, learn components of safety planning for children with problematic sexual behavior and how to address safety planning with families, and learn about strategies to enhance successful reunification of siblings.</p>

8:30 -- 10:15	<p>Keynote — Safety, Healing & Hope in Sibling Sexual Abuse Work: Some Thoughts for Consideration</p> <p>Andrew Monroe MSW, LICSW, LCSW</p> <p>This session will teach participants how choice of words can impact thoughts and behaviors when addressing problematic sexual behavior of youth, what youth with lived experience wish they would have known prior to treatment, and components that may reduce likelihood of problematic sexual behaviors.</p>

10:30 --12:00	T1	<p>Assessment of Children and Adolescents with Problematic and/or Illegal Sexual Behaviors</p> <p>Andrew Monroe MSW, LICSW, LCSW</p> <p>In this presentation participants will learn about how school-age and adolescent assessments can be structured as well as learn at least two differences between school-age and adolescent assessments.</p>
	T2	<p>Mind the Gap: Providing Developmentally Appropriate Interventions to Young Adults</p> <p>Tamara Woods LCSW, CSOT</p> <p>This presentation will explore the individuals that fall within the “gap” age range of 18-22 years old. These individuals are unique in that they are considered legal adults, but developmentally, may not be functioning at an adult level. Clinicians must consider these issues when identifying appropriate interventions. This presentation will briefly discuss the development of sexual schemas and maturity, focusing on the reality in which most of these young adults are living, such as influence of social media, lack of accurate information regarding sexual relationships and sex. Additionally, this presentation will discuss of the role that the broader United States culture and society has played in</p>

		aiding or inhibiting the sexual development of young adults, how they interact with sexual partners as well as where they see themselves in the world of sexual activity. Finally, topics such as adjudication vs treatment and developmentally appropriate interventions will be shared, along with techniques of addressing sexual harm within this population.
	T3	<p>So How Do We Know? Using Real Time Client Feedback to Guide Our Supervision</p> <p>John Lynch</p> <p>How do we know that we are building rapport, trust, and connection with clients? Do we use intuition? Guess work? Hope? Using Scott Miller’s Session Rating Scale (SRS) combined with the use of Motivational Interviewing (MI), participants will learn how to gauge, in real time, their effectiveness in relationship building. Participants will also see a case study over twelve meetings using the SRS and MI skills to determine whether these tools helped client success.</p>
1:30 – 3:00	T4	<p>Client Preparation for the Polygraph Exam – Part 1</p> <p>Monty Buettner, Matthew Griffith NCC, LPC, CCSOT (LCPC-MT), and John Cummings</p> <p>Taking a polygraph exam can be very stressful, even for the truthful clients. We all hope for a passing polygraph by our clients, and proper preparation in advance of the exam can assist in getting there. Contrary to this, improper preparation can likely cause false positive or inconclusive results, even if the client is being truthful. All three testing types (Maintenance, Full Disclosure, & Single Issue) allows for the therapist or probation officer to assist the client with proper preparation for the exam. This session, presented by a Polygraph Examiner and a Therapist, will discuss the Do’s and Don’ts when preparing the client for the polygraph exam.</p>

Sexuality has shifted and grown throughout human history and continues to do so, particularly with the younger generation of youth who have pushed for sex positivity, explored alternate relationships, and increased immediate access to more sexual content than has ever existed on the devices in their pockets. As sexual expression has evolved, so too must we wrestle with our own understanding of “normal”, “atypical”, and “deviant” sexuality, especially as it relates to helping our clients develop healthy sexual futures.</p>

Andrew Monroe MSW, LICSW, LCSW, is a psychological clinician with the National Center on Sexual Behavior of Youth (NCSBY), Center for Child Abuse and Neglect (CCAN), and Child Study Center at Oklahoma University Health Sciences Center in Oklahoma City. He completed his undergraduate studies at Auburn University where he received a Bachelor of Arts in Social Work. He completed his Master of Social Work at The University of Alabama in Tuscaloosa, AL.

Mr. Monroe has experience working with and developing programs for youth with problematic sexual behaviors as well as trauma survivors in urban and rural settings. He is a licensed polygraph examiner in Oregon and travels throughout the State to provide exams. He has offices in both Portland OR and Stevenson WA. Monty is a Member in Good Standing with the American Polygraph Association, the American Association of Police Polygraphists, and the Northwest Polygraph Examiner's Association.

Matthew Griffith NCC, LPC, CCSOT (LCPC-MT)

Matthew Griffith NCC, LPC, CCSOT (LCPC-MT) is currently, working in private practice at Restored Outlook Counseling LLC. specializing in treating harmful sexual behaviors among adjudicated adolescents. Matthew lives in the beautiful state of Montana and provides treatment services to Oregon and Montana. Matthew's journey started as a Juvenile Probation Officer in Klamath County. After feeling not equipped enough to assist in encouraging behavioral change, Matthew enrolled in a graduate program in Clinical Counseling through Oregon State University.
